Total Potential THC = THCa \* 0.8777 +  $\Delta^9$ -THC

Total Potential CBD = CBDa \* 0.8777 + CBD

ND = Non Detect; LOQ = Limit of Quantitation; Cannabinoids for flower and trim reported as received.
